Statistics for July - August 2005

Sales and Redemptions

Total assets for all funds increased in July by \$240 billion, or 2.9 percent, to \$8.5 trillion. Money market funds had a net cash inflow of \$22.7 billion compared to an inflow in June of \$3.0 billion. Other funds (equity, hybrid, and bond) had a net cash inflow of \$18.9 billion, compared to an inflow of \$12.3 billion in June. New sales of non-money market funds, the purchase of new shares excluding reinvested dividends, were \$116.2 billion in July, down from \$117.7 billion in June. The value of non-money market assets appreciated by \$189.4 billion in July, following an appreciation of \$63.1 billion in June.

Total assets of **equity funds** increased by \$198.6 billion, or 4.4 percent, to \$4.7 trillion. There was a \$10.1 billion net cash inflow to equity funds in July, compared with an inflow of \$6.2 billion in June. The market value of assets appreciated by \$187.6 billion in July. Equity funds had an inflow of \$83.6 billion year-to-date, compared to an inflow of \$127.5 billion in the first seven months of 2004.

Total assets for **hybrid funds**, which invest in a mix of stocks and bonds, increased 2.0 percent, or \$10.9 billion, to \$555.9 billion. In July, there was a \$1.5 billion net cash inflow for these funds, compared to an inflow in June of \$2.1 billion. Hybrid funds have experienced an inflow of \$21.7 billion year-to-date, compared to an inflow of \$27.5 billion during the same period in the previous year.

Bond funds experienced a cash inflow of \$7.4 billion, while their total assets increased by \$3.2 billion, to \$1.3 trillion. The market value of bond funds assets decreased by \$7.2 billion, after adjusting for net sales and reinvested dividends. The assets of taxable bond funds increased by 0.3 percent, while the assets of tax-exempt bond funds increased by 0.03 percent. The 2005 inflow is \$22.0 billion, compared to an outflow of \$23.9 billion through July of 2004.



Assets of taxable and tax-exempt **money market funds** increased \$27.3 billion, to \$1.9 trillion, an increase of 1.4 percent for taxable money market funds and an increase of 1.9 percent for tax-exempt funds. The 2005 outflow of \$45.0 billion is less than the outflow for the first seven months of 2004, \$108.1 billion.

Liquidity Ratio

The liquidity ratio for bond and hybrid funds decreased from 7.2 in June to 7.1 percent in July, while the ratio for equity funds decreased from 4.0 to 3.9 percent (figure 4).

Weekly Flows

In August, there were outflows from equity funds of 0.6 percent of total assets, with losses of 1.8 percent (figure 6a). Bond funds had outflows of 0.2 percent and losses of 0.5 percent.

Index funds had monthly outflows of 0.5 percent and losses of 2.2 percent. Aggressive growth funds had outflows of 0.5 percent and losses of 1.6 percent. Small-cap funds had inflows of 0.8 percent and losses of 2.9 percent.

Technology funds had outflows of 2.1 percent and losses of 4.7 percent (figure 6b). There were inflows to real estate funds of 0.4 percent and losses of 5.3 percent.

There were outflows to international funds in August of 0.4 percent of assets and gains of 0.6 percent. Latin American funds had inflows of 0.1 percent and gains of 2.9 percent. Japan funds had outflows of 3.0 percent and returns of 5.3. Pacific funds that do not invest in Japan had outflows of 2.2 percent and losses of 3.0 percent of assets. Emerging Markets funds had outflows of 1.6 percent and losses of 4.1 percent.

Capital Market Returns and Volatility

The S&P 500 ended August 31 at 1220.3, a decrease of 1.2 percent from the beginning of the month. The 12-month gain was 10.5 percent at month-end. The annualized volatility for the daily return on the S&P 500 was 10.3 percent.

The 12-month average return on the Citigroup Bond Index was 4.3 percent for August. Volatility decreased to 3.0 percent (figure 8).


Price-Earnings Ratio


The macro projections for the growth of earnings of the Standard and Poor's 500 index over the next two years have been revised in the third quarter of 2005 to 5.5 percent from current levels. During the second quarter of 2005 the price-earnings ratio for the Standard and Poor's Small-Cap 600 Index fell to 21.3 from 21.4 (figure 9).



Sales of Mutual Funds














(percent of Total Financial Assets)





(percent of Total Assets)

















(percent of Total Assets)



(percent of Total Assets)




(Shaded Regions Indicate Periods of Rising Fed Funds Rate)






S&P500 Daily Returns and Volatility








S&P Price-Earnings Ratios

S&P500 Price Earnings Ratio and the Growth of Earnings





Real Rate of Return on Nonfinancial Corporate Equity


