

**PARTICIPATION AGREEMENT UNDER  
THE MAIN STREET LENDING PROGRAM**

**TRANSACTION SPECIFIC TERMS**

THIS PARTICIPATION AGREEMENT UNDER THE MAIN STREET LENDING PROGRAM is dated as of the Agreement Date and entered into by and between Seller and Buyer to govern the purchase and sale of the Participation in the Loans and the other Transferred Rights, in accordance with the terms, conditions and agreements set forth in the Standard Terms and Conditions for Participation Agreements under the Main Street Lending Program (the "Standard Terms") published as of June 11, 2020 on the website of the Federal Reserve Bank of Boston (the "Federal Reserve Bank of Boston's Website"), which is currently at <http://www.bostonfed.org>. The Standard Terms are incorporated herein by reference without any modification whatsoever except as otherwise agreed herein by the Parties and as specifically supplemented and modified by the terms and elections set forth in the Transaction Summary and Sections A through C below. The Standard Terms and the Transaction Specific Terms together constitute a single integrated Participation Agreement under the Main Street Lending Program governing the Transaction. With respect to the Transaction, the Parties agree to be bound by the Standard Terms and the Transaction Specific Terms set forth herein.
