Lowell Five Bancorp, MHC ("MHC") and Lowell Five Bancorp, Inc. ("SHC") received The Federal Reserve Bank's approval of application to become a mutual holding company and stock bank holding company, respectively, by acquiring The Lowell Five Cent Savings Bank ("Bank") on June 9, 2011. The reorganization was successfully completed on September 1, 2011. The enclosed FR Y-6 Annual Report of Bank Holding Companies and response to report items, below, have been prepared following the Instructions for Preparation of Annual Report of Bank Holding Companies FR Y-6 General and Report Item Instructions December 2007, 2008, 2009, and 2010 ("Instructions").

The fiscal year end of Lowell Five Bancorp, MHC is December 31<sup>st</sup>. Lowell Five Bancorp, MHC reported consolidated assets of \$919,368,000 as of December 31, 2013. Lowell Five Bancorp, MHC meets all audit requirements under the FDIC's Part 363 – Annual Independent Audits and Reporting Requirements. Currently, the independent public accountant firm of McGladery and Pullen, LLP is engaged to audit the consolidated financial statements on an annual basis and prepares and presents the independent auditors' report within the stated deadline date to the Audit Committee of The Lowell Five Cent Savings Bank.


