REPORT ITEM

1. Annual Report to Shareholders

Braintree Bancorp MHC (the "Company") is a mutual holding company and, therefore, has no shareholders. The Company also owns directly 100% of the outstanding shares of the capital stock of its banking subsidiary, The Braintree Co-operative Bank (the "Bank"). Consequently, there is no annual report to shareholders included with this report.

2a. Organization Chart

As stated above, the Company owns 100% of the outstanding shares of the capital stock of the Bank. The Bank, in turn, owns 100% of the outstanding capital stock or other ownership interest of three additional subsidiaries, Braintree Investment Services LLC, Bay Colony Enterprises, Inc. and Braintree Co-operative Realty, Inc. (collectively, the "Bank Subsidiaries"). A diagram reflecting this corporate structure is included as Exhibit A to this report.

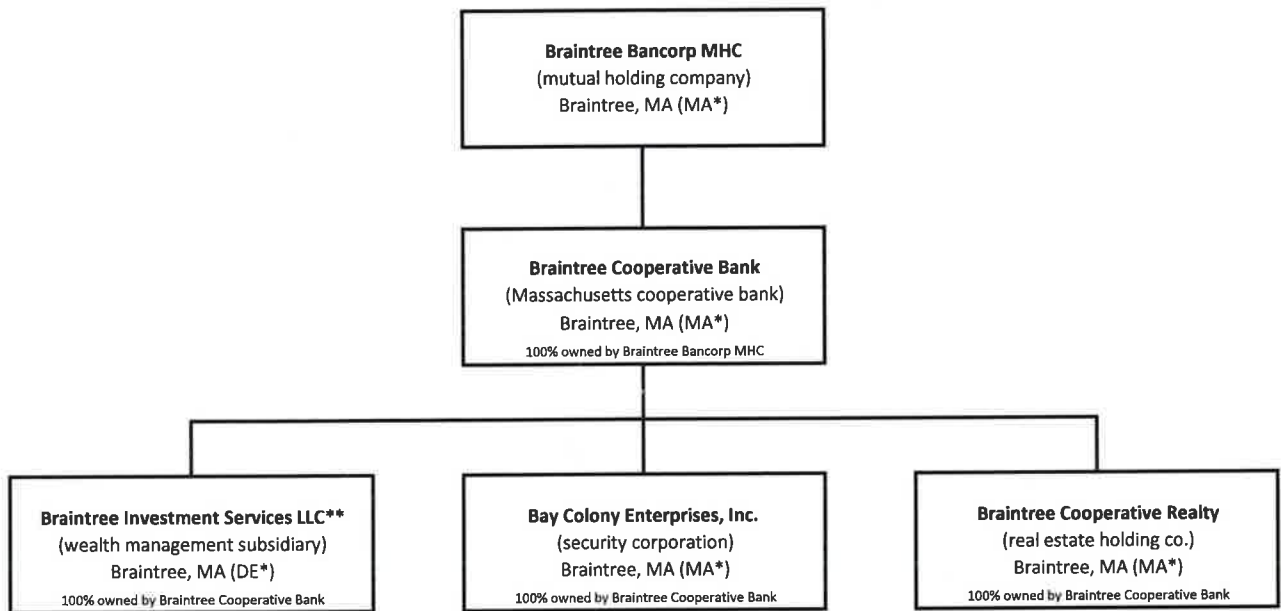
