Re:	Trends in median income in Massachusetts, Greater Boston, and the city of Boston

This memo describes the recent trend in real median household income in Massachusetts, Greater Boston, and the city of Boston from 1999 through 2004. Over this period, real median household income in the city of Boston grew 2.2 percent versus declines of 1.9 percent in Greater Boston and 2.8 percent in the Commonwealth.

However, there was considerable variation in median incomes over this time period: The 2001 recession appears to have hit some areas harder than others, and certain New England states, including Massachusetts, are still recovering. Prior to the recession, household income grew more rapidly in the city of Boston relative to the surrounding area and the rest of the state. Yet the city also suffered a larger drop in median income during the recession compared to other areas in the Commonwealth. As you suspected though, over the past two or so years (2002-2004), median income has grown more rapidly in Boston proper, though the city has not yet reached its pre-recession peak. In contrast, median incomes in Greater Boston and Masachusetts fell between 2002 and 2003 and grew only a barely perceptible (and not statistically significant) amount from 2003 to 2004.
